We prove our commitment in our Annual Report.

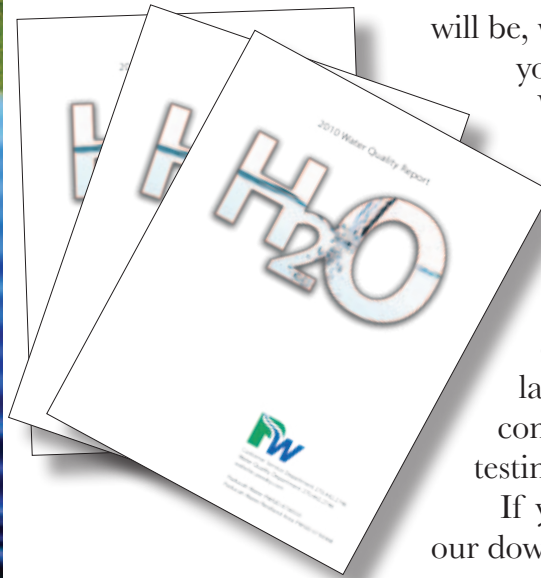
Paducah Water's top priority is, and always will be, water quality. Easy to say, but how do you, our customers, know we mean it?

Water Treatment Facility Dedicated

On May 7, 2010, Paducah Water rededicated the Eighth Street Water Treatment Facility in honor of long-time Water Works Commissioner, W. J. "Jim" Brockenborough.

Earlier this spring, Jim lost his battle with cancer. Jim served on PW's Board for more than 30 years, 20 of which, he served as Chair of the Board.

Jim was instrumental in the construction of the 26-year-old facility.

In 1979, Jim was appointed to the Commissioner's of Waterworks Board by then-Mayor John Penrod. The water plant in use at the time was more than 100 years old and extremely unreliable.

In comments on the dedication day, long-time board member and current chair, Bob Johnston said, "I remember when the Mayor appointed Jim, he said, 'Clean this mess up,' and Jim took that as a challenge."

Efficiency and the insistence of "not playing politics" were hallmarks of Jim's tenure on the board and as chair. He even refused to allow his company, Hannan Supply, to bid on any work or materials that could be used by Paducah Water, to avoid the appearance of impropriety.

Although Jim was a humble man and avoided the spotlight of recognition, before his death, he did learn of the plans to name the plant in his honor and was very pleased.

According to his family, Jim was most proud of the work he did for Paducah Water. Without his leadership over the last nearly half-century, PW would not be in the position the company is today - financially sound, and producing the highest quality water at the best price possible.
